Families who receive financial aid from LGA are not eligible for this subsidy. Effective tuition with TIP\$12,952		
PIP/ PRESCHOOL INCENTIVE PROGRAM = \$1,000 towards tuition for students in kindergarten who attended a Jewish preschool; the Harold Grinspoon Foundation offers this incentive program to all families, whether or not the family receives financial aid from LGA. Effective tuition with PIP and TIP \$11,952

The actual cost of educating a child at LGA is well over \$20,000 for each student, whether full pay or financial aid recipient.

The difference between what LGA receives through tuition and fees and the cost of educating a child is made up through fundraising from families and friends, as well as substantial operating support from the Harold Grinspoon Foundation and the Jewish Federation of Western Massachusetts.

REFUND POLICY

- Withdrawal: If the student(s) enrollment is canceled by the family, tuition responsibility is:
 - + 5% through March 31
 - + 50% between April 1 and June 15
 - 100% on or after the June 16
- **Exemptions:** We understand that family plans change. Students are exempt from the withdrawal protocol above if:
 - + The family moves/relocates 50+ miles away
 - The Administration or Director of Student Services initiates withdrawal
 - + Other unique circumstances are approved by the Administration Team

PLEASE BE AWARE THAT FINAL YEAR-END GRADES, COMMENTS, TRANSCRIPTS AND REPORT CARDS WILL NOT BE RELEASED NOR WILL ANY STUDENT BE PERMITTED TO PARTICIPATE IN GRADUATION UNTIL ALL OUTSTANDING BALANCES INCLUDING TUITION, FEES, AFTERCARE AND ELECTIVES ARE PAID IN FULL.

NO STUDENT WILL BE ALLOWED TO REGISTER OR ATTEND CLASSES AT THE START OF ANY NEW SCHOOL YEAR UNTIL ALL OUTSTANDING BALANCES HAVE BEEN PAID IN FULL.

LGA MAY ASSESS LATE CHARGES FOR EACH LATE PAYMENT, RETURNED CHECK OR DEFAULTED DIRECT DEBIT.

FAMILIES ARE RESPONSIBLE FOR APPLYING FOR TIP AND/OR PIP IF APPLICABLE. IF THE FAMILY NEGLECTS TO APPLY FOR TIP AND/OR PIP, THEY ARE RESPONSIBLE FOR PAYMENT OF THE CORRESPONDING TUITION INVOICE.
